REGULAR MEMBERS

MEMBERSHIP CLASSIFICATION

REGULAR MEMBERS

Regular Members shall be selected by the Board of Directors on the basis of such standards and qualifications as may be determined by the Board of Directors from time to time. Each Regular Member shall have the right to one (1) vote at all meetings of the Institute. For further clarity, Regular Members may (i) cast its one (1) vote in elections for the Board of Directors, (ii) serve as an Officer of the Institute, and (iii) serve on the Board of Directors and its Member Committees, if permitted by the Act.

A Regular Member that is an entity shall appoint one (1) representative and two (2) alternates who are authorized to act for it in the affairs of the Institute. The Board of Directors may elect to make the contact information of any Regular Member (or in the case of a Regular Member that is an entity, the designated representative of the Regular Member) publicly available by any means now existing or hereafter created (e.g. by way of an Institute website, print Directory, et cetera). In order to be a Member, Regular Members shall pay dues in accordance with these Bylaws and in accordance with such policies and at such rates as the Board of Directors establishes from time to time.

ASSOCIATE MEMBERS

Associate Members shall be selected by the Board of Directors on the basis of such standards and qualifications as may be determined by the Board of Directors from time to time. No Associate Member shall have any voting rights. No Associate Members may: (i) cast any vote in elections for the Board of Directors, (ii) serve as an Officer of the Institute, and (iii) serve on Member Committees or on Committees of the Board of Directors. An Associate Member that is an entity shall appoint one (1) representative and two (2) alternates who are authorized to act for it in the affairs of the Institute. Associate Members shall be entitled to such additional rights and privileges as the Board of Directors may determine from time to time. In order to be a Member, Associate Members shall pay dues in accordance with these Bylaws and in accordance with such policies and at such rates as the Board of Directors establishes from time to time.
